### **NEWS AND EVENTS**

**Sixth meeting of the Steering Committee of the Regional Programme for South Eastern Europe (PSC RP SEE) takes place in Vienna 9 December 2014, Vienna:** The 6<sup>th</sup> PSC meeting held with participation of the PSC Members, Ambassadors and representatives of the Permanent Missions of the SEE and donor countries and regional organizations, discussed the evaluation of the RP SEE, acknowledged the results of UNODC work in region in 2014 and endorsed the workplan for 2015. An important result of the meeting was the approval of the concept of UNODC partnership with the region in 2016-2019. The meeting endorsed the respective concept note and work schedule in accordance with which UNODC has already started the development of the new Regional Programme in close consultations with all partners. *For info: Ekaterina Kolykhalova* 

**UNODC** presents work in South Eastern Europe to Standing open-ended intergovernmental working group on improving the governance and financial situation of UNODC (FinGov)

20 November 2014, Vienna: The UNODC regional team presented the outcomes of work and results achieved in the region in 2013 to the FinGov. The RP SEE was presented to the forum for the first time and it has acknowledged the good results of UNODC in the region in the spirit of the Inter-Regional Drug Control Approach. **14 October 2014, Skopje, the former Yugoslav Republic of Macedonia:** Following the launch in Vienna in March 2014 and presentations in the region, the above UNODC Report was presented in Skopje at the Mini-Dublin Group meeting with participation of the EU. According to the report, the country is unique in the region in that it borders the two main entry points of the Balkan Route into the EU - Bulgaria and Greece and is a major transit point for the western branch of the Balkan Route; at the same time, it is an important location for heroin storage and repackaging. *For info: Valentina Anchevska* 

# DRUG PREVENTION, TREATMENT AND CARE

UNODC - Lions Quest "Skills for adolescence" - first follow-up session organized to scale up programme results

**3 December 2014, Belgrade, Serbia:** The first follow-up session (in a series of three) was organized under the UNODC - Lions Club International Foundation 'Skills for Adolescence' programme in order to scale up programme results and support further implementation of the pilot phase of the programme. #### **CRIMINAL JUSTICE**

UNODC holds a Workshop on Promoting the International Standards on the Treatment of Women Prisoners in South Eastern Europe

**15-16 December 2014, Vienna:** UNODC held the above workshop under the umbrella of the gender component of the RP SEE. #### **CCP in Albania holds annual meeting**

22 December 2014, Tirana: The annual CCP meeting in Albania was held in partnership with the General Directorates of Customs Administration and the State Police with the aim of reviewing the results of the CCP work in the country in 2014, the future goals, the sustainability of the Durres JPCU, local, regional and international cooperation and awareness raising. #### Albanian officers visit the Italian port of Gioia Tauro and Foreign Officials visit the Port of Durres

**26-28 November 2014, Gioia Tauro, Italy:** Customs and Police officers of the Durres JPCU and prosecutors of the Serious Crime Prosecution office from Tirana had a study visit to the Italian port of Gioia Tauro where they met with representatives of the Agenzia delle Dogane (Customs) and the Guardia di Finanza (Financial Guard). It was agreed to intensify the information exchange and enhance operational cooperation, including in the form of Controlled Deliveries. On **8-10 December 2014, Durres** JPCU hosted seven officials from the Republic of Yemen and the Kingdom of Saudi Arabia accompanied by UNODC officer for Middle East and North Africa who got acquainted with the developments and implementation of the CCP with particular focus on cooperation between the Customs and Police as partner entities to the JPCU. *For info: Ela Banaj* 

#### CCP in Bosnia and Herzegovina commences implementation phase

17-28 November 2014, Mostar, Bosnia and Herzegovina: A two-week training was organized for the JPCU officers from the Indirect Taxation Authority and the Border Police of Bosnia and Herzegovina with participation of other national law enforcement agencies: State Investigation and Protection Agency, Directorate for Coordination of Police Bodies and Agency for Education and Professional Training, as well as from the Slovenian Customs Directorate. The training is the first segment of the structured professional learning concept of the CCP, combining on-site theoretical and practical training, e-learning modules and work-study visits, including mentoring and advisory visits. #### Joint Port Control Unit (JPCU) at Durres Port seizes counterfeit goods

17 October 2014, Durres, Albania: The Durres JPCU confiscated counterfeit designer goods from a container coming from China, transiting Durres Port to Kosovo (UNSCR 1244). The operation was based on the intelligence acquired by the JPCU and supported by the Department of the Fight against Economic Crime. It resulted in the seizure of goods worth EUR 50,000 and USD 150,000 as well as the detention of the entrepreneur. This is the first case of seizure of counterfeit goods at Durres Port coming though containers. For info: Ela Banaj

This hands-on practical workshop focused on reviewing a case study on trafficking in children related to the Western Balkans. The methodology of analysis of concrete cases of trafficking in children and the development of action plan for responsible stakeholders was discussed in details.
